# A Message from Your Chair

On May 9th, for the third time in my life, I testified before a committee of the Ohio legislature to give testimony concerning pending legislation. I gave testimony before the House Pension Committee in support of House Concurrent Resolution 6, urging the Ohio legislature to urge the Ohio Congressional delegation to repeal the Windfall Elimination Provision (WEP), which penalizes those who have public pensions and would be entitled to Social

Security from Social Security law.

After testimony was given, the bill was amended to also include eliminating the Government Pension Offset (GPO), which penalizes the spouses of those who received government pensions. The resolution passed the committee unanimously and awaits action by the whole house. Thanks to Representatives. Angela King and Phil Plummer for sponsoring the resolution and Rep. Bob Young, Chair; Rep. King, Vice Chair; and Rep. Mary Lightbody, ranking minority member of the House Pensions Committee, for passing this important measure.

I would like to thank Jim Douglas for accepting an appointment to be the 2nd vice chair when there was a vacancy. Jim has previously served as the District 3 representative. Due to health concerns, Jim has chosen not to run for that position.

I value his advice and wish him well in the future.

In September, I will be running for Chair, John DiPietro for Treasurer, and Merrill Asher for first Vice Chair, positions we already fill. Connie Dailey and Rick Lawrence, present district representatives, will fill the other Executive Committee positions after the September Annual Meeting. All five candidates are running unopposed. We all look forward to continuing advocating for you to preserve and defend the pensions we have all worked so hard for.

Please reach out to your former co-workers to join us in our mission. The greater our numbers, the more attention that OPERS, the Ohio legislature, and the Ohio congressional delegation will listen to us present our position for you. Presently, we represent approximately one out of every five OPERS beneficiaries.

Please also attend local chapter meetings to make your voice known and keep up with what PERI is doing for you.

Thank you for your service, your support, and your interest. We need and appreciate it, to do what we need to do for you.

# **Legislative Report**

#### **Ohio Budget Update**

At the time of this writing, our team at Byers, Minton & Associates is awaiting the final Ohio Main Operating Budget Conference Report to be finalized by House and Senate conferees for Fiscal Years 24-25.

The Ohio Senate recently passed its version of Ohio's main operating budget by a party-line vote of 24-7 following a 2,100-page omnibus amendment. Senate Republicans have touted the budget passage as balanced, trimming the size of state government, pursuing tax cuts and education reform, among many other initiatives. Meanwhile, Senate Democrats stated the Senate-passed budget is out of touch and not in balance with priorities that are "out of touch" with Ohioans across the state.

After likely non-concurrence by the House, select members from each chamber will meet in Conference Committee to sort out differences between the House, Senate, and Executive proposals. The final bill will be sent to the Governor for signing and line-item veto opportunity by June 30th at midnight, as required by Ohio's Constitution.

#### **Ohio Elections**

Ohioans will also head to the voting booth on August 8th for the Issue 1 special election, which would require any future proposed constitutional amendments to pass with at least a 60 percent supermajority threshold instead of the current 50 percent plus one requirement for approval. Issue 1 has seen several legal challenges as proponents believe the measure is necessary to prevent special interests from buying their win into Ohio's Constitution. Opponents of Issue 1 believe the guick turnaround toward the special election signals an effort to defeat a reproductive rights amendment proposal on November's ballot. As a reminder, July 10th is the deadline to register for the August special election. Both absentee by mail and early in-person voting begins on July 11th. Polls will be open on August 8th from 6:30 a.m. to 7:30 p.m. For more information on Ohio's upcoming elections, please visit www. ohiosos.gov.

#### **Pension-Related Statehouse News**

On May 10th, the Ohio Senate passed SB 6 on another partyline vote (26-7), which would prohibit state pensions and other public institutions from investing for reasons other than returns and benefits. Specifically, the bill aims to stop investments based primarily on environmental, social, and governance policies. The bill sponsor, Sen. Kirk Schuring, said it is preventive rather than critical of existing investment practices in Ohio. The bill would still allow individuals with self-directed retirement plans to choose ESG funds.

The legislation is now before the Ohio House Financial Institutions Committee for further consideration.

Additionally, the Ohio House Pensions Committee passed HCR 6, sponsored by Representatives Phil Plummer and Angela King, and urges Congress to repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). While the resolution will not directly impact the potential passage of federal WEP/GPO legislation, it signals to Congress from the Ohio House that a solution must be found to assist those affected by the federal law.

#### Federal Legislation - WEP/GPO

PERI continues to monitor the legislative activity around WEP/GPO repeal at the Federal level. As of this letter, HR 82 – Social Security Fairness Act of 2023 has 281 bipartisan congressional co-sponsors, including nine of Ohio's fifteen congressional delegation members. While it remains unlikely the legislation will pass as introduced initially, several members of committee leadership have hinted at reforming the complicated WEP/GPO formula to provide relief to those affected by the provisions.

As a reminder, HR 82 (as introduced) seeks to enact the following:

- This bill repeals provisions that reduce Social Security benefits for individuals who receive other benefits, such as a state or local government pension.
- The bill eliminates the government pension offset, which in various instances reduces Social Security benefits for spouses, widows, and widowers who also receive government pensions.
- The bill also eliminates the windfall elimination provision, which sometimes reduces Social Security benefits for individuals who also receive a pension or disability benefit from an employer that did not withhold Social Security taxes.
- These changes are effective for benefits payable after December 2023.

**Note:** The Windfall Elimination Provision (WEP) impacts people who benefit from Social Security and a government pension. The provision changes how the Social Security benefit is calculated, resulting in a lower benefit for those impacted. This can significantly impact those who rely on their pension and Social Security benefits for retirement.

# A Message from Your Executive Director

Peri Members,

I want to thank all of you for your continued support of PERI. We have been very busy at the state office following legislation and working on ways to increase our membership. A few weeks ago, we sent our new

retiree letters to over 7,000 recent OPERS retirees to gain additional voices for our mission. The dues mailings are one of our most significant expenses each year, becoming more noticeable with the increase in postage and printing costs.

If you know anyone receiving an OPERS pension, please help us spread the word about our association. There is power in numbers, and with over two hundred thousand OPERS recipients, we want to educate them on why we matter.

In May of this year, Protect Ohio Pensions, INC (POP5) sent their dues renewal to PERI members, and it has become apparent that many were confused by the mailing. To be clear, PERI does not affiliate with or endorse Protect Ohio Pensions (POP5). Our emails and social media posts have informed members about the difference between PERI and other retiree associations.

PERI began in 1948 as the Public Employee League of Ohio and later, was renamed Public Employee Retirees, Inc. (PERI). We have always advocated for the benefits of OPERS pension recipients regarding health care and COLA (Cost of Living Adjustments).

PERI is confident that your OPERS pension is secure with minimal risk of special interest groups, corporations, brokerage firms, or legislators changing the Ohio defined benefit plan to a defined contribution plan. About twenty years ago, a few special interest groups sounded off with negative opinions regarding the defined benefit but that has not been a threat in OHIO since 2011. OPERS is against any actions to change your benefit plan, and we continually monitor legislation and listen for any attack in Ohio or any other pension state. Should any discussion be presented in Ohio, PERI holds a cash reserve to use as legal fees to fight for our members.

The adjacent column will provide you with the many actions PERI has taken from 2000 – 2023 and continue working on daily for our members. # Know the difference from others... What is PERI? What has PERI Done?

#### 2000-2010

- Lobbied for and won increased pension base-pay, and 5th ad hoc adjustment.
- Stopped attempts to convert our system from defined benefit to defined contribution.
- Exposed truth behind the "Buy Ohio" cover.
- Secured a permanent 3% COLA.

#### Medicare and Covid 19

The COVID-19 Public Health Emergency ended on May 11, 2023. This may affect your Medicare coverage for some services.

#### **COVID-19 Testing**

Original Medicare does **not** cover over-the-counter at-home tests as of May 11, 2023. Original Medicare **does** cover two other kinds of COVID-19 tests when the test is ordered by a physician or other health care practitioner. The two kinds of covered tests are PCR tests (which identify genetic material) and antigen tests (which are often called rapid tests). There is no out-of-pocket cost to you.

Medicare Advantage Plans must cover COVID-19 tests. However, there may be out-of-pocket costs as of May 11, 2023. Contact your plan to learn more about costs. Medicare Advantage Plans may also continue to cover over-the-counter at-home tests at no cost. Contact your plan to learn if this supplemental benefit is offered, and how to access it.

#### COVID-19 Vaccine

Original Medicare Part B covers COVID-19 vaccines and boosters, regardless of whether you have Original Medicare or a Medicare Advantage Plan. You pay nothing for the vaccine or boosters.

Health officials recommend the COVID-19 vaccine and timely booster shots for maximum protection against the virus. Speak with your doctor if you have questions or concerns.

Bring your red, white, and blue Medicare card with you to your vaccination appointment, even if you have a Medicare Advantage Plan. If you do not have your card on you, your vaccine provider may ask you for your Social Security number so that they can look up your Medicare information.

#### **COVID-19 Treatments**

#### **Monoclonal antibodies**

Medicare covers certain monoclonal antibodies to treat COVID-19 for some people. You owe no cost-sharing (deducible, coinsurance, or copay) for covered treatments.

#### Inpatient and outpatient treatment

Medicare Part A covers medications you receive as a hospital inpatient. Medicare Part B covers medications you get from a health care provider as an injection or infusion. An example of an injected medication is Remdesivir. You may owe cost-sharing (deductible, coinsurance, or copay) for these treatments. Medicare Advantage Plans also cover these treatments. Contact your plan to learn more about costs.

#### **Prescription drugs**

Paxlovid is a medication used to treat COVID-19 that is available at the pharmacy. The government has paid for a certain amount of Paxlovid. While the supply of Paxlovid from the government lasts, you pay no cost-sharing. After the supply has been used, Part D covers Paxlovid. Paxlovid may be on your plan's list of covered drugs, or you may have to ask your plan to make an exception and cover the drug. You may owe cost-sharing (deductible, coinsurance, or copay).

#### Telehealth Benefits

**Until December 31, 2024**, Medicare covers telehealth visits whether you:

- Live in a rural or urban area
- Get the services at home or in health care settings

Medicare covers hospital and doctors' office visits, mental health counseling, and other visits via telehealth. If you have a Medicare Advantage Plan, it must cover telehealth services as well. Contact your plan to learn about costs and coverage.

**After December 31, 2024**, coverage for telehealth benefits may be more limited.
