Chairman's Column

When I first became your chair in September 2021, we needed a legislative agent due to the retirement of John Gilchrist. We were very fortunate to hire Greg Bennett of Byers, Minton, & Associates, who served us extremely well for two years. Greg has now moved to Government Affairs Lead at Owens Corning. We wish him well in his new endeavor. Mara White of Byers Minton has now undertaken our representation, and we look forward to a

successful partnership with her assisting in our lobbying efforts.

We continue our efforts to support and defend the defined benefit pension and benefits for which we have all labored and on which we depend. The OPERS Board has approved seeking a four percent increase in the employers' contribution. This would raise the employers' contribution from fourteen percent to eighteen percent. This requires legislative action and would be the first change in the contribution rate since 2008. The PERI board supports this increase to keep OPERS strong and to maintain and possibly increase the money available for the health retirement accounts (HRA). Bills are presently pending in the legislature which would increase the employers' contribution rates for police and fire, as well as state teachers. We will monitor these bills because it is likely that any increase for those retirement systems would happen across all five state retirement systems.

On the national level there are as of April 4, 2024, 311 co-sponsors of HB 82 in the United States House of Representatives and 53 co-sponsors of S.B.597 in the United States Senate. Both bills would repeal the WEP/GPO, which unfairly punishes those of us who had both public and private employment by reducing our Social Security benefits. Both Ohio's senators and ten of the fourteen Ohio house members (there is presently one vacancy) are co-sponsors.

I testified before the Ohio House Pension Committee on May 6, 2023, on behalf of HCR 6, which urges all of the Ohio Congressional delegation to support the repeal. The resolution unanimously passed the House on December 6, 2023. I testified before the Ohio Senate Government Oversight Committee on February 28, 2024, in support of the resolution and a vote was scheduled in committee on April 10 (this was written on April 5).

To strengthen our organization and its influence, we are pursuing contacts with the alumni associations of the state's university retirees, who are also OPERS recipients, for our mutual benefit.

Since I last wrote, I have visited Morgan and Monroe Counties and am scheduled to speak at an officer's training in Bellville in April, a district meeting for District 4 in May, and a district meeting for District 2 in June. I am looking forward to meeting with more of you to hear your concerns and inform you of what our organization is doing for all of us.

Ohio Legislative and Political Update

We hope this update finds you in good health and spirits. I want to take this opportunity to share some important public policy updates with you as the Ohio legislature gets ready to return from an event primary campaign season.

Post-Primary Political Update

The battle between sitting Speaker Stephens and Senate President Matt Huffman for the speakership in the 136th General Assembly which begins in 2025, has been set. Huffman's team was able to pick off three (3) incumbent members of Team Stephens. There were also several open seats which were won by folks who look to be aligning with Huffman. However, the races where incumbents lost featured incredibly negative ads, and there is frustration among members due to the intraparty "violence".

Bernie Moreno beat out Matt Dolan and Frank LaRose for the Republican nomination for US Senate setting up a match up with Sherrod Brown who has roughly \$13 Million in his campaign account.

Legislative Update-HCR 6 is Getting a Committee Vote!

Both chambers are returning to cap square the week of April 8 and at least now intend to hold both committee and session through this month and the month of May. Their largest task is to allocate both nearly \$2 billion in capital bill appropriations and \$750 Million in Strategic One Time Funding dollars that are mostly relief funds disbursed to states during COVID. Both of these pots of funds are intended for bonded, one-time improvements that would not require ongoing assistance.

HCR-6 To urge Congress to repeal the Windfall Elimination Provision and the Government Pension Offset is set for a Committee Vote in the Senate on Wednesday, April 10th. We expect no problems receiving an affirmative vote and the next step will be to encourage Senate leadership to bring HCR-6 to the floor senate floor for a vote.

State of the State Address

Governor Mike DeWine will give his annual state of the state address this coming Wednesday, April 10th. I will include a synopsis in our next legislative update of the Governor's remarks.

STRS Board Court Proceedings

Governor Mike DeWine Appointed Wade Steen to the STRS board in May of 2023, he then quickly removed him without a publicly given reason, and appointed Brian Perera in his place. Parera is a well-known and generally respected government affairs professional. Steen sued, and this last week the Ohio 10th Court of Appeals heard arguments regarding whether DeWine was within his power when he

removed Steen.

It is generally believed that underpinning this conflict is a disagreeing opinion regarding the investment professionals who are contracted by the board and the quality of their work product. Because of the conflict and opposing views, the campaigns for the elected retiree board seats have become increasingly competitive.

The resolution of this case will likely define the Governor's power as it related to all of the public retiree boards.

Gregg Bennett is no longer with Byers, Minton & Associates and will not be our Legislative Counsel. We are sad to see him go but happy that he has found a job as Chief Government relations officer with Owens Corning. Mara White will be taking his place as PERI's Legislative Counsel.

Mara joined Byers, Minton, & Associates in 2021 and serves as Director of Government Affairs advocating on a broad variety policy and regulatory issues on behalf of clients. Prior to joining the firm, Mara was a member of the campaign finance team to former Congressman Pat Tiberi. She then joined the campaign of Pat's successor and current Congressman, Troy Balderson during the 2018 special election in Ohio's Twelfth District. Mara eventually went on to serve as a Legislative Aide in the Ohio House where she worked on legislation in the transportation, public safety, and energy sectors as well as gained valuable experience working on Ohio's biennial operating budget.

Mara completed her undergraduate degree in Political Science and Philosophy at Belmont University in Nashville, Tennessee. In addition to politics, Mara is passionate about mental healthcare and is currently working on her master's in clinical counseling at Capital University in Columbus.

Happy Spring, I hope everyone is doing well.

The dues renewal mailing in November of 2023 had many errors, starting with the wrong date on your voucher. A third-party company used our old documents, causing

Part D Coverage Phases

The cost of your Medicare Part D-covered drugs may change throughout the year. If you notice that your drug prices have changed, it may be because you are in a different phase of Part D coverage. There are four different phases—or periods—of Part D coverage: the deductible period, the initial coverage period, the coverage gap, and catastrophic coverage. As you spend money on your covered drugs, you progress through the coverage periods until the new calendar year starts. Your Part D plan should track your coverage period for you, and this information should appear in your monthly statements.

Until you meet your Part D deductible, you are in the **deductible period**. During this time, you will pay the full negotiated price for your covered prescription drugs. While deductibles can vary from plan to plan, no plan's deductible can be higher than \$545 in 2024. Some plans have no deductible, and some plans don't apply a deductible for certain drugs—usually generics—at certain pharmacies.

After you meet your deductible, your plan will help pay for your covered prescription drugs. This is your **initial coverage period**. Your plan will pay some of the cost, and you will pay a copayment or coinsurance.

You enter the **coverage gap** when your total drug costs—including what you and your plan have paid for your drugs—reaches a certain limit. In 2024, that limit is \$5,030. While in the coverage gap, you are responsible for 25% of the cost of your drugs. The coverage gap is also sometimes called the donut hole.

In all Part D plans in 2024, you enter **catastrophic coverage** after you reach \$8,000 in out-of-pocket costs for covered drugs. This amount is made up of costs you pay and some costs that others pay. As of 2024, during this period, you owe no copays or coinsurance for your covered drugs for the remainder of the year. Not all costs count towards reaching this cap, though. Costs that do not help you reach catastrophic coverage include monthly premiums, what your plan pays toward drug costs, the cost of non-covered drugs, and the cost of covered drugs from pharmacies outside your plan's network.

Beginning in 2025, the structure of Medicare Part D will change. There will be only three coverage phases—the deductible, the initial coverage period, and a zero-cost phase after an out-of-pocket cap is reached. Additionally, your out-of-pocket costs for covered drugs will be limited to \$2,000 in deductibles, copays, and coinsurance. Also starting in 2025, you have the choice to spread out-of-pocket Part D costs over the year. This won't reduce the total amount owed over the year, but it can allow you to spread costs over 12 months. For example, you could pay your deductible over the course of the year, rather than all at once at the beginning of the year. Whether this type of payment plan will be beneficial will depend on your circumstances and preferences. Remember that these changes are not in effect until 2025.
