#### Chairman's Column

I have now started my final year as your chairman. The PERI constitution limits the chair to 2 two year terms. The term limitation ensures that new ideas continue to come into the organization and that it does not become the organization of one person.

It has been my pleasure since the last column to preside over the 50th annual meeting of our organization. Our partnership with OPERS has kept our pension system the best in Ohio and one of the best in the country. We will continue the fight to protect our defined benefit pension system from all who may wish to destroy it. Since the last newsletter I have visited chapters in Knox, Cuyahoga, Stark, and Morgan Counties and continue to be strengthened in my position as your chair by the determination and dedication of our membership. We are looking at setting up online meetings for those members who live out of state.

The biggest issue in my time as your chair is the elimination of the WEP/GPO penalty imposed upon the Social Security of OPERS retirees and their surviving spouses. I have also been contacted by members who live outside of Ohio as to how they can influence their representative and senators to vote for the repeal. Your dedication has seen both our Ohio United State Senators as co-sponsors of the Senate bill to accomplish this, and eleven of the fifteen Congressional House Representatives from Ohio being co-sponsors of the House repeal bill. There are 329 co-sponsors of the House bill and 62 co-sponsors of the Senate bill. There are the necessary 218 signers of the discharge petition to take the House bill outof committee and it now awaits a vote by the entire House. The Ohio US Representatives who signed the petition are Representatives Landsman, Brown, Carey, Sykes, Beatty, Kaptur, Balderson, and Joyce. If one of these is your representative, thank them. Call Speaker Johnson and Majority Leader Scalise to set the bill for a vote. Be prepared to ask your representative to vote for HB 82 when it comes up for a vote.

As you may meet your state senator and representative or candidates for those offices, politely educate them on the strength of OPERS and the necessity to continue to keep it strong. Point out to them that the defined benefit pension is the best pension system and that holding an elected position in Ohio makes them a member of that system and a beneficiary in the future.

Let us all continue to do what we can to keep and strengthen our pension system for which we worked. We, at the state level, are nothing without the support of all of you.

Our vigilance on the critical Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) bills, HR 82 and SB 597, continues. Our legislative representative, Mara White, and Board Chair Richard Ross have provided insightful articles on these issues. With the discharge petition moving HR 82 out of committee, we are hopeful that U.S. House Speaker Mike Johnson, in DC, will bring this bill to the floor for a vote. This progress is a testament to the power of our collective advocacy efforts, and each of you plays a crucial role in this.

### Ohio Legislative and Political Update

We hope this update finds you in good health and spirits. I want to take this opportunity to share some important public policy updates with you as the Ohio Legislature gets ready to head to the Ballot Box next month.

#### **Legislative Update**

Since the previous quarterly report, the legislature has not returned for session while they focus on their campaigns. It is standard during an election year that the General Assembly will break for the months of July through October to focus on their campaigns. Members will return just after Election Day for what is historically a marathon few weeks referred to as the "lame duck session".

However, with the battle for the House Speakership largely unsettled, there is little direction regarding how much (or how little) work either Chamber is prepared to do during the Lame Duck Session.

#### WEP/GPO Repeal

September was a HUGE month for HR82 which would repeal both WEP and GPO. A discharge petition was initiated by the sponsors and received enough signatures to bypass the House Committee process. What happens now is that after 7 calendar days the Sponsors may make a motion for a full House Vote, the speaker must also recognize this motion. The Sponsors have stated that they remain committed to HR 82 receiving full floor vote, however Congress typically breaks in October so we will likely see a November vote.

#### This Quarter in Retirement System News

As was discussed by Director Carraher during our annual meeting, one of our main goals is to ensure that OPERS is held harmless for the sins of other systems. There has been some discussion in the Ohio Retirement Study Commission about the benefits of combining the 5 different systems. This is something that we wouldn't support and is not desirable from the perspective of the OPERS in-house leadership as well.

However, after another difficult month for STRS where their leadership resigned after a narrowly defeated vote of no-confidence it will be important that we remain vigilant that OPERS remains focused on its current set of beneficiaries and not what other systems may or may not need.

#### OSHIIP an Empowering Resource for Ohioans During Medicare Open Enrollment

COLUMBUS – I am excited to announce the start of our Ohio Senior Health Insurance Information Program's (OSHIIP) annual statewide Medicare Checkup events.

These free, virtual and in-person events are a tremendous opportunity for the nearly 2.5 million Ohioans on Medicare and in open enrollment, which runs Oct. 15 to Dec. 7, to get unbiased help sorting out health insurance coverage that will best suit their needs for next year.

The events cover Medicare basics, plan comparisons, prescription drug coverage, financial assistance, and costsaving tips. Prior to Oct. 15, the focus is on educational sessions. Once open enrollment begins, OSHIIP's Medicare experts provide personalized plan comparisons and one-on-one counseling.

With Medicare plan coverage changing annually, it is essential that Ohioans review their options and research covered prescription drugs and in-network health care providers, even if they are interested in staying in their same plan. We are also warning Ohioans to guard against advertising and sales pitches that overreach as well as scams.

Ohioans may encounter a flood of ads promoting "the best" Medicare plans. Caution is advised as some offers might seem too good to be true. Know what marketers are prohibited from doing. To combat scams, guard personal information and avoid giving money in exchange for services like enrollment help or prescription plan signups.

At the Ohio Department of Insurance, we are here to help. OSHIIP's Medicare experts are ready to empower Ohioans on all of these fronts. The state's official Medicare educational and counseling support program, OSHIIP saved Ohioans more than \$42.5 million over the past year through its efforts assisting those on Medicare.

## PERI 2024 ANNUAL MEETING

PERI Treasurer John DiPietro introduced the Franklin County Sheriff Department Color Guard, who performed the flag ceremony.

Chair Richard Ross led the National Anthem and called the meeting to order.

Jim Range, District 9 Representative, gave the invocation.

Treasurer DiPietro led the Assembly in reciting the National Anthem. He then gave opening remarks and introduced the morning keynote speaker, OPERS Executive Director Karen Carraher.





Ms. Carraher presented an update on pension and health care funding. She gave a 5-year history of OPERS investment returns, sharing that the 2023 investment results positively impacted funding. She assured the audience that OPERS remains strong

and adequately funded.

On health care, Ms. Carraher said that although OPERS is not currently funding the health care plan, the board approved an allowance increase for 2025. She shared that the Medicare base allowance will increase by \$50 from \$350 to \$400 through 2030 and that Pre-Medicare will remain at \$1200.

Ms. Carraher reviewed several bills and how they could impact the pension fund and its members.

AMBA gave a short presentation about the benefits that they provide for members.



The Assembly broke to attend a breakout session that they chose at registration. The choices for breakout sessions included OPERS Education, Attorney Generalnew scams, Legislative Networking & Grassroots lobbying, and AMBA benefits.



The members reassembled in the Ballroom for lunch.

Ms. Garcia presented the Spirit of PERI award to the winner, Donna Riley, PERI president from Adams County. Adams County Treasurer William Jones accepted

the award on her behalf.

The Education Committee raffled off baskets from the 11 PERI Districts to the winning attendees.

Jen Sotlar, from AMBA, held a drawing for a tablet. Beverly Wolford, from the Muskingum County chapter, was the lucky winner.

Mr. Ross recognized outgoing District Representatives Bonnie Mitchell (District 6) and Rosemary Dahmann (District 4).









Mr. DiPietro introduced Ohio Secretary of State Frank LaRose as the afternoon's keynote speaker to the Assembly.

Mr. LaRose spoke about election integrity in the state of Ohio and said that we can be confident that our elections

are fair, and our ballots are secure.

After Mr. LaRose's presentation, we conducted our business meeting. Mr. Ross led by presenting the Chair's report.

Mr. Ross shared information regarding the legislative progress of the WEP/GPO bills. He urged members to contact their U.S. Congressmen and encourage them to sign a discharge petition.



Mr. Ross also asked members to get to know their state senators and representatives to influence them when we need them to support our position on legislative issues.

Lastly, Mr. Ross shared that the more members we

have, the more effective he is as the Chair. There is strength in numbers, and our impact is more significant when retirees band together with the same goal of protecting our benefits.



Treasurer DiPietro presented the 2023 Financial Report.

Representatives from Districts 2, Sharon Drerup, and 10, Mark Faust.

Mr. DiPietro held the 50/50 drawing and presented the prize to JoAnn Aylsworth.

Mr. Ross led the singing of God Bless American and adjourned the meeting.


















